

**Minutes of the Meeting to discuss the NRDWP Annual Action Plan (2017-18) of  
"Assam" State**

1. Annual Action Plan meeting for 2017-18 with the officials of Public Health Engineering Department, Assam was conducted on 23.02.2017 in the Conference room, 4<sup>th</sup> floor, Pt. DeendayalAntyodayaBhawan, CGO Complex, New Delhi. The meeting was chaired by Shri SatyabrataSahu, Joint Secretary (Water), MDWS, GoI. The list of participants is given in annexure.
2. In his opening remarks, JS (W) desired that the opening balance under NRDWP should be kept within the permissible limits in order to avail funds in 2017-18 (April).
3. It was informed that the State of Assam will be allocated tentatively Rs. 274.30 crore (excluding MDI) for NRDWP during 2017-18 as per existing guidelines. State should plan targets under NRDWP keeping in view availability of nearly Rs. (274.30 + 44.31 + 39.41) 358.02crores, considering the higher expected share from the State. The State Government is also likely to receive about some amount under Water Quality Mission, subject to their timely utilization of the same. State Government has proposed to cover 297 number Water Quality Habitations and 770 number Partially Covered Habitations, totaling 1067 Habitations during 2017-18.
4. It was deliberated that the amount of allocation in 2017-18 will be scheme/ project based. There will be no investment in new projects. The amount will be reserved for ongoing schemes with priority in the order of 100%, 75-100%, 50-75% and 25-50% physically completed water supply schemes respectively. However there will be exception to take up new project in verified ODF SAGY villages, Arsenic/ Fluoride affected habitations.
5. Further, it was deliberated that the projects having physical progress between 0-25% will be financed from the State funds as decided by Govt. of India.
6. During 2016-17, the physical progress of schemes is given below:

7. During deliberations, it was informed by the State Secretary that project amounting to Rs. 39.90 crores for 297 water quality affected and Rs. 127.53 crores for 770 partially covered habitations is proposed to be taken up during 2017-18.
8. JS (W) also deliberated that partially covered (PC) habitations having water supply between 0-25 lpcd should be given priority. The criteria for prioritizing would be as per the order mentioned in point no. 4 above. The State Secretary pointed out that there were 4681 water quality affected habitations and 6761 non water quality habitations in this range as on 01.04.2016. Out of which 484 (211+273) have been taken to be covered during 2016-17 and 251 (108+143) during 2017-18. State Government was insisted to cover all these habitations on priority.
9. The State was also advised to update data on IMIS with immediate effect during this Yearly Data Updation period.
10. State was advised to dovetail funds under MGNREGS/ FFC grant for better O&M of Water Supply Schemes.
11. Suitable water tariff should be collected to make the schemes sustainable.
