Subject:- Submission of pending UC and ASA under NCEF funding.

Madam / Sir,

An amount of Rs. 221.30 Crore was distributed to above States during March, 2013 and February-March, 2015 for installation of Solar power based dual pumps for piped drinking water supply. However, it has been observed that most of the States have not yet submitted the final UCs and ASA for the utilization of above funds. The State wise position of pendency of UCs is as under:-
